Registration is now open for the January 2008 MCAT. MCAT wants you to have the best registration experience possible. The following information will help you navigate successfully through the MCAT Scheduling and Registration System. Following the tips below will prevent lost seats, multiple credit card charges, and lost connections.

- If you are taken to the Web page that says "Welcome to MCAT Registration and Thank You for Your Patience," you have arrived at a waiting room because the system is busy. If you close this page or refresh your browser, you will lose your turn and your wait starts over. When you are taken to the login page, you will have one minute to enter your username and password.
- Once you are in the system, some actions may take up to a couple of minutes to complete, especially the payment page. Do not refresh your browser, which could derail your action.
- Use only the application controls ("Save and Continue," "Previous," etc.) to move from section to section. Don't use browser buttons such as "Back," which could disrupt your connection. Do not open multiple browsers or more than one browser window; this can slow the system down.
